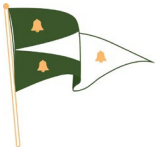

By signing this agreement, I acknowledge that I have received, read, and agree to all the terms and conditions outlined in the "General Marina Rules and Terms of Agreement". I understand that there are no refunds under this agreement after Jan. 31<sup>st</sup>. I also understand that a valid credit card must be on file with Three Belles Marina at all times or no service can be provided. Payment in full is due before the vessel is released or upon invoicing. Monthly customers further understand and agree that should they wish to remove the vessel before all payments are made, the outstanding balance for the full contract year, (summer and winter season) is due and will be charged to the credit card on file as one lump sum. I agree to pay all service charges and collection fees on unpaid invoices should collection become necessary. I further authorize the use of my credit card to fully pay any balance outstanding for more than seven days. Verbal authorizations will not be accepted, and this agreement is not complete until signed and returned to Three Belles Marina.
